

**ATTACHMENT A**

The property to be searched is a black Samsung phone seized from Jeremy Lynn Rasmussen, to be called the "Device." The Device is currently located in the evidence room of the Marshals' Albany, New York office, located in the U.S. Courthouse at 445 Broadway.

This warrant authorizes the forensic examination of the Device for the purpose of identifying the electronically stored information described in Attachment B.

**ATTACHMENT B**

1. All records and information on the Device described in Attachment A that relate to violations of 18 U.S.C. § 2250(a) and involve Jeremy Lynn Rasmussen since December 1, 2014, including but not limited to:

- a. Phone calls placed, received or missed by the Device;
- b. Text and voicemail messages;
- c. Photographs and images;
- d. Cellular-site data; and
- e. Records of Internet use.

2. Evidence of user attribution showing who used or owned the Device at the time the things described in this warrant were created, edited, or deleted, such as logs, phonebooks, saved usernames and passwords, documents and browsing history.

As used above, the terms "records" and "information" include all of the foregoing items of evidence in whatever form and by whatever means they may have been created or stored, including any form of computer or electronic storage (such as flash memory or other media that can store data) and any photographic form.
