## AN ORDINANCE

AMENDING ORDINANCE NO. 26,528, AS AMENDED, BY REPEALING AND REENACTING SECTIONS 1 AND 2, PERTAINING TO A CONTRACT WITH APPRISS, INC. FOR SERVICES IN CONNECTION WITH THE PRESCRIPTION DRUG MONITORING PROGRAM; AND AUTHORIZING CONTRACTS WITH PARTICIPATING COUNTIES, MUNICIPALITIES AND LOCAL PUBLIC HEALTH AGENCIES.

BE IT ORDAINED BY THE COUNTY COUNCIL OF ST. LOUIS COUNTY, MISSOURI, AS FOLLOWS:

SECTION 1. Ordinance No. 26,528, as amended, is amended by repealing and re-enacting Sections 1 and 2 as follows:

SECTION 1. The County Executive, on behalf of St. Louis County, is authorized to execute a contract with Appriss, Inc. to provide administrative services in connection with the program for monitoring, prescribing and dispensing of schedule II, III and IV controlled substances, pursuant to Ordinance No. 26,352. The contract shall provide for Appriss, Inc. to provide use of its PMP AWAREXE web portal to covered practitioners; for Appriss, Inc. to be responsible for maintenance of related computer hardware and software; and for a term of three years, with County to have the option to renew the contract for up to two additional one-year terms. The contract shall provide for compensation to Appriss, Inc. for the first, second and third years of the contract in an amount not to exceed \$78,500.00 per year, for year four in an amount not to exceed \$80,462.50, and for year five in an amount not to exceed \$82,474.06; for Appriss, Inc., to permit the City of St. Louis to purchase a subscription into the program at a cost not to exceed \$39,500.00 per year; for Appriss, Inc. to permit other Missouri counties, [and] municipalities and local public health agencies authorized by Missouri state law to carry out public health functions to purchase subscriptions into the program, at a cost not to exceed \$7.00 per covered practitioner, plus an administrative fee proportional to population; and for such other terms and conditions as are approved by the County Counselor.

SECTION 2. The County Executive, on behalf of St. Louis County, is authorized to execute contracts with the City of St. Louis, [and] Missouri counties and municipalities, and local public health agencies authorized by Missouri state law to carry out public health functions to facilitate access to the Appriss system for covered practitioners

within the City of St. Louis and such counties and municipalities; and for the City of St. Louis and such counties, [and] municipalities, and local public health agencies to reimburse St. Louis County for the applicable costs paid by St. Louis County pursuant to Section 1. Such contracts shall contain such other terms and conditions as are approved by the County Counselor.
