PO Schoolcraft's father called "City Hall," and
spoke to ~~the~~ Dep Mayor Slyder's assistant. The
father said that his son was never told why he is
on R/D. SGT Bonilla reached out to PO
Schoolcraft who said he was never told why he
is on R/D.

I told SGT Bonilla that Dr Lanstein was
away, so could not report in on exact conversation, but I
read some notes which confirm she "gave feedback," and more.
I tell that our policy is to ~~not~~ make the MDT know why
~~they~~ they are being placed in R/D (even if they may
disagree). We also try to direct MDT to place them
can get help, as Dr. Lanstein clearly did.

I told SGT that Dr Lanstein would call in
PO Schoolcraft as soon as she returns, ^{and} to answer any
questions he may have. SGT Bonilla said that was
fine - it ~~should~~ could wait for Dr Lanstein's return.

I explained to Mos that I called him immediately upon my return from a 2 wk vacation b/c I received msg that his father made a complaint down town that I never told Mos the reason why he is on R/D. Since we had discussed that in detail at his initial & subsequent visits, I empathetically expressed an uncertainty of how he may not have wanted to tell his father the reason why he was on R/D. To make sure that he has a clear understanding of why he is on R/D, I again explained in detail that he is on R/D b/c he had significant physical manifestations of stress that were causing much discomfort & would benefit from treatment & further monitoring.

Mos said he no longer has these physical signs of stress even though he is still facing the same stresses as before while on R/D. He is at present dead of PCT daily with complete all day long - not attempting to hide, but not using his attempt (in his opinion) as regular E/P circle.

I again reemphasized stress management training so that next time he is faced with new increased stresses, he won't have a recurrence of the chest pain, headache, memory, report memory, etc. that he had of several months ago to come to PES. He said he bought both books I recommended & stated reading them, but not that helped since most he didn't know before. He thought the Burns book was kind of corny & preferred the Ellis book. He ~~had~~ ^{had} bought both books to today's appointment & had bookmarked them, ~~so~~ ^{so} not very far into them (he hasn't read much of them). He said he called a few people I recommended & got one job offer & one under \$400/week. I told him they don't provide CBT ^{+ books} if he is not in treatment CBT. He said he would call back to his provider & to more of his part HMO plan so I can make sure the provider are in-network. Mos expressed an openness of the situation.
